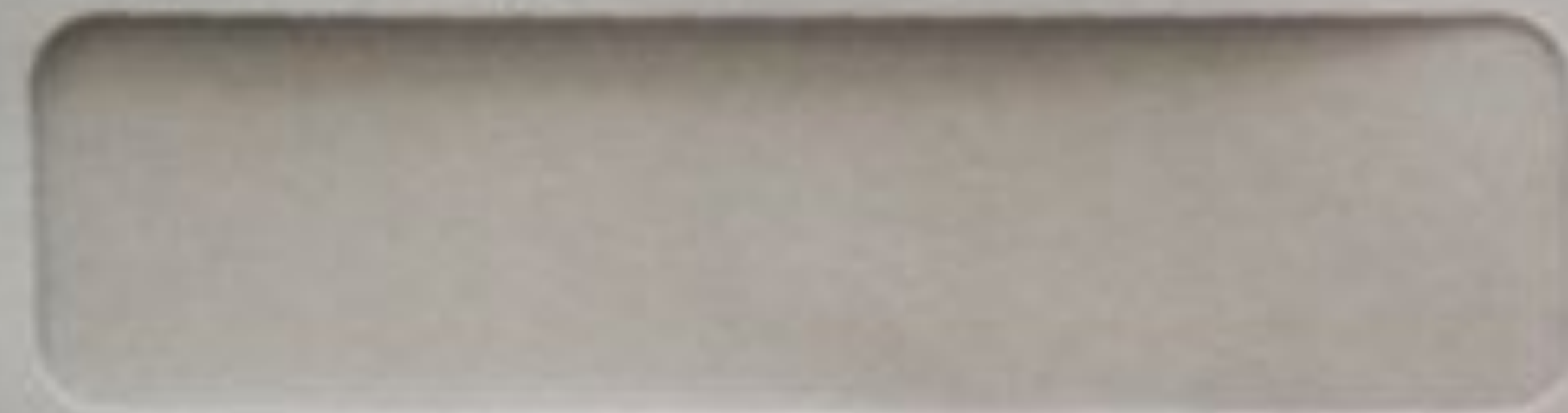

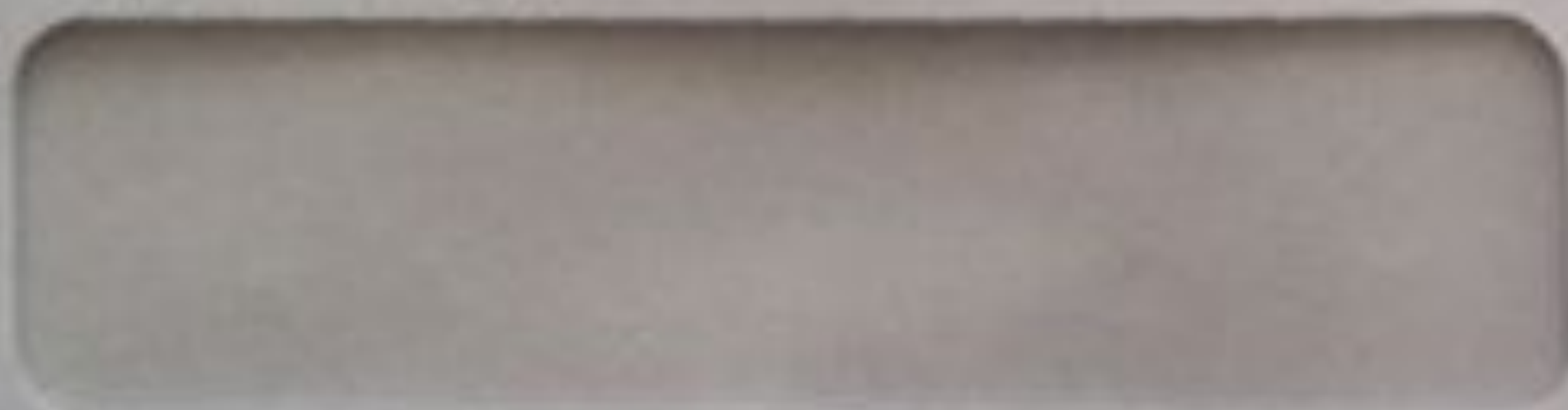

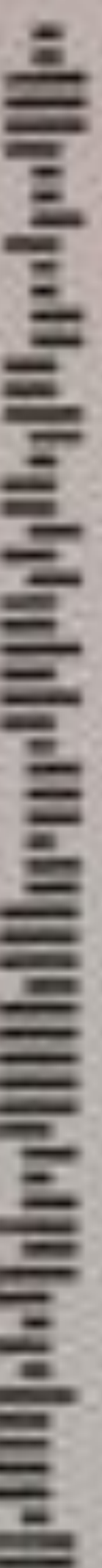

Who you vote for is private, but whether or not you vote is a matter of public record.

The enclosed voter report card shows your vote history and how it compares to others in North Carolina. It is designed to make it easy for you to keep track of how often you choose to go to the polls.

Unfortunately, some elected officials in North Carolina aim to make voting more complicated by requiring voters to show a photo ID at the polls. But the photo ID requirement doesn't kick in until 2016. They are intentionally trying to make it harder for people like you to vote. But these new laws aren't in effect yet. Here's what you need to know:

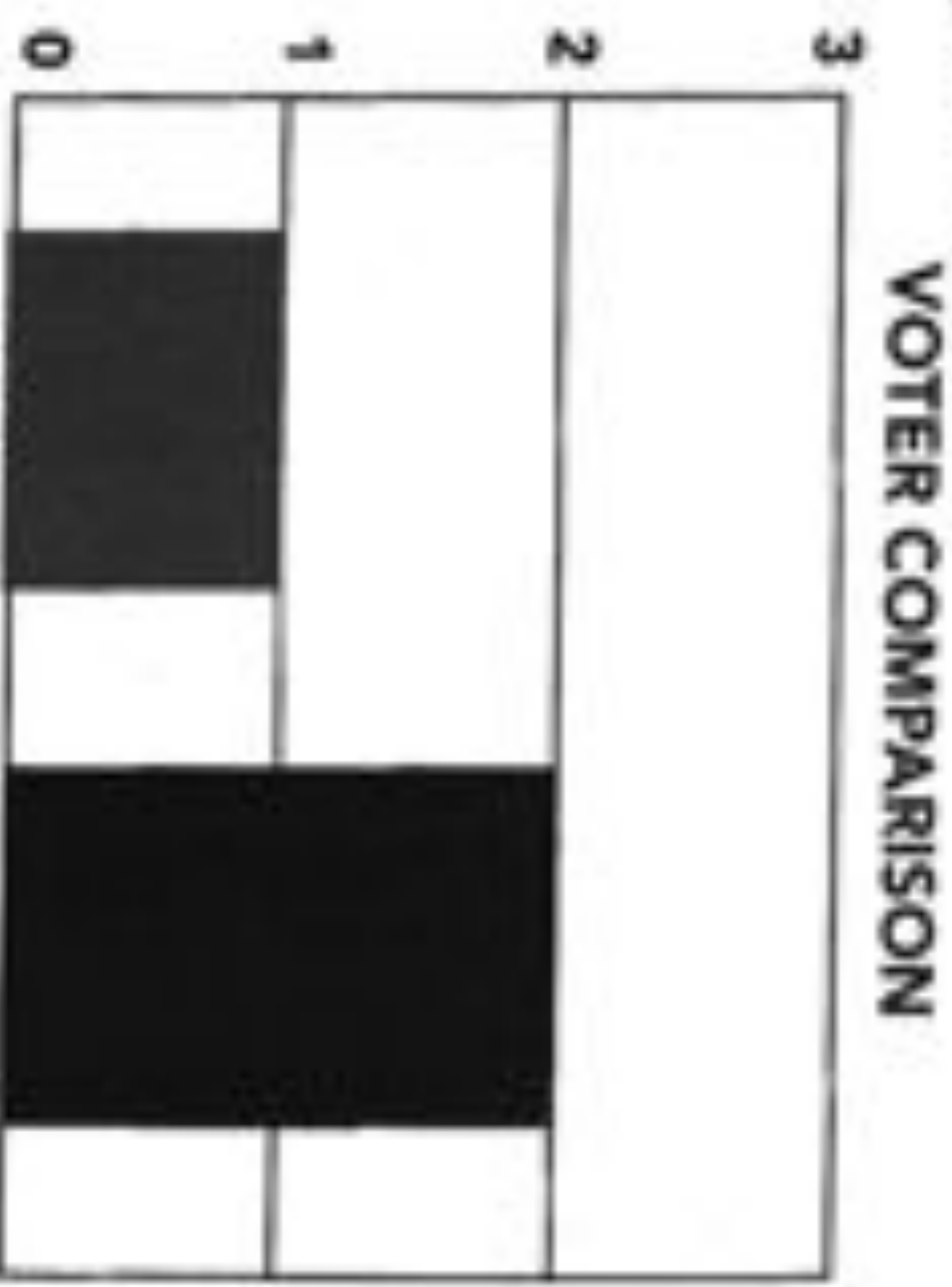
- **You do not need photo ID to vote in the 2014 General Election.**
- The new photo ID law means photo IDs aren't required in order to vote until 2016.

We know you care about North Carolina, which is why you vote. Join hundreds of thousands of your friends, family and neighbors by voting early between October 23rd and November 1st at 1:00PM. Or vote on Election Day, **Tuesday, November 4th, 2014. Polls are open from 6:30AM to 7:30PM.** For more information, visit the State Board of Elections at www.ncsbe.gov.

Unfortunately, some North Carolina elected officials are trying to limit everyone's access to the polls by passing restrictive voter ID laws, eliminating same day registration and reducing the early vote period. Their main goal is stopping people like you from voting. But don't believe the misinformation – the new voter ID laws are not in effect this year. While you may be asked for photo ID when you go to vote this year, you **DO NOT HAVE TO PROVIDE PHOTO ID** for this election.
